### 2. Why do we collect your personal data?

- Contact the person from whom we may obtain reference about you in order to be informed about whether you are fit for the job,
- Be informed about the position to which you want to be assigned, your wage expectation, information on whether you would except to be assigned to other positions and determine your start date of employment.
- Determining whether youwill be able to use the companyvehicles when needed,
- Determine if your age is suitable for the position to be proposed to you and ensure compliance with the regulation on the principles and procedures of the employment of child and juvenile workers.
- Ensure that you are easily recognized by our human resources department when you come to the company to make an interview,
- Be able to contact the job applicant and the preparation of his/ her personal fileif he is recruited,
- Determine whether there are any conditions that may interrupt your work during the term of the employment contract and ensure compliance with the article 75 of the Law on Military Penalty numbered 1632.

## 3. Which method do we use for processing your personal data and which legal reasons serve as a basis for their collection?
